阿尔及利亚符合性证书 (CoC)

The Certificate of Conformity of Algeria

根据阿尔及利亚中央银行第16/DGC/2009号文件，所有进入阿尔及利亚境内的产品必须获得由国际检验机构联盟（International Federation of Inspection Agencies，简称IFIA）的独立第三方成员机构颁发的符合性证书（Certificate de Conformité，简称CoC）。另外，从2009年7月27日起，所有运往阿尔及利亚货物的支付交易必须通过信用证（L/C）进行。德国莱因TÜV是国际检验机构联盟成员之一。我们会根据阿尔及利亚国家标准（IANOR）或国际标准（ISO，IEC）对产品进行验证，其测试还可与TÜV，GS，CE，CB等服务相结合以节约客户成本。

As regulated by note no 16/DGC/2009 of the Central Bank of Algeria, a Certificate de conformity(CoC)issued by independent third parties being member of IFIA(International Federation of Inspection Agencies) is necessary for products to be imported to Algeria. Since 27 July 2009,payment transactions for all imports to Algeria must be processed via Letters of Credit (L/C). TÜV Rheinland Group is a member of the IFIA.we will certify products according to relevant Algeria (IANOR) or international standards(ISO,IEC),and the testing can be combined with other services provided by TÜV Rheinland,e.g.TÜV,GS,CE,CB to control costs.

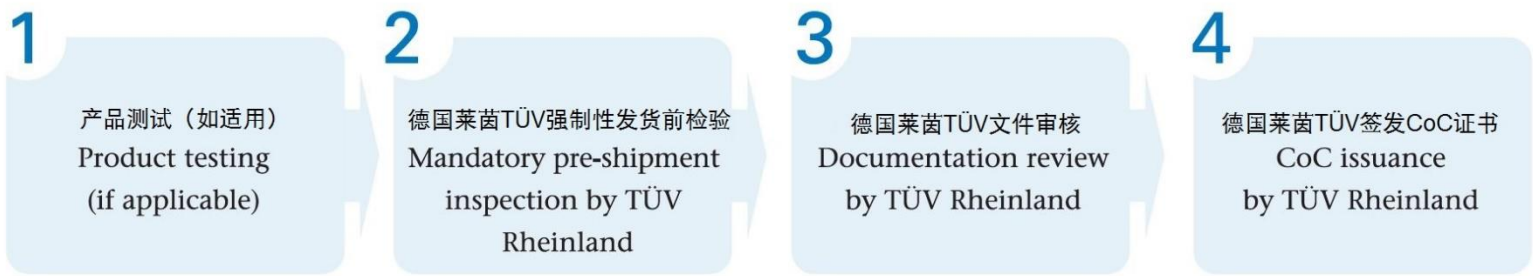
